



Financial Letter

The Board of Directors and the senior management team of Places for People (PfP) are committed to fiscal transparency. This letter is meant to provide additional information and clarity regarding the FY 21 financials for Places for People.

Places for People ended FY 21 with a positive bottom line for the fiscal year. The surplus for the fiscal year is \$4 million. The surplus resulted from several unbudgeted factors and conditions that created the favorable variance.

• PfP's largest funding source is the Missouri Department of Mental Health. DMH approved a Quality Incentive Payment (QIP) for Places for People. PfP met all six metrics of quality evaluated by DMH. The total QIP is \$780,482. We are proud that we have met these quality performance metrics for the past three years. However, these funds are never guaranteed, and we do not budget for them on an annual basis.

• PfP applied for a PPP loan in order to ensure that we were able to retain 100% of our employees and maintain the quality of services during the COVID-19 pandemic shut- downs when we were unsure of the future of face-to-face billing. We received forgiveness of the loan and the interest associated totaling \$2,398,285.10 in revenue.

Going forward we don't have either of these factors included in the FY 22 budget. The PPP loan was a one-time opportunity and the QIP is never guaranteed. The Board of Directors and the senior management team are reviewing and exploring options to reinvest the FY 21 budget surplus. The following factors are being considered:

• Places for People currently has debt service of \$8 million on the new health center. Funds may be used to repay some debt.

• Places for People does not have a significant cash reserve fund. Some funds may be invested into a reserve account to be used in a financial crisis.

• It is getting more challenging to maintain services at the same level due to the workforce shortage and COVID -19 related obstacles. There is a growing need to expand services due to opioid use increases, critical needs for youth and young adults and increasing wait lists for outpatient therapy and psychiatry. Funds may be used to address workforce retention and engagement and move closer to meeting the current demand for services.

Highlights

JULY 2020

Missouri Foundation for Health (MFH) awarded the St. Louis Regional Center of Excellence in Behavioral Health \$900,000 over three years, beginning in July 2020. A primary goal of the Center of Excellence is to increase access to evidence-based practices and improve client outcomes, while enhancing the recovery-orientation and effectiveness of the regional system of care.

The Board of Directors of Places For People is pleased to announce that they have selected Laura McCallister as its new President & CEO after an extensive national search process. Joe Yancey, the former CEO of Places For People, announced his retirement after serving in the role since 2011.

AUGUST 2020

Joe retires and Laura takes over as CEO.

A visit from Missouri Governor Mike Parson shone a spotlight on Places for People's response to the COVID-19 Pandemic and the necessity of a quick pivot of telehealth. When the COVID-19 Pandemic started, Places for People devised a phased response to protect the health and well-being of those we serve and staff members. This included a quick pivot to providing services primarily through telehealth methods (video and telephone), which was made possible by changes to MoHealthNet policies. This shift to telehealth allowed Places for People to remain engaged with our current caseload, as well as continue to engage those still in need of support.

Places for People hires as the organization's first Diversity and Inclusion Officer. Places for People created this position as a commitment to its mission and values: to improve the physical and behavioral health of the individuals, families, and communities we serve, as well as those who support the provision of these services.

SEPTEMBER 2020

Places for People continues to enhance services to best meet the needs of our community. Our organization received a threeyear accreditation by CARF after a virtual visit in September.

Adaptability and flexibility have been two important traits during the COVID-19 pandemic, and that has extended to Places for People's longest-running fundraiser. The 18th Annual Places for People Golf Tournament was moved from being in-person to being virtual on Friday, September 11th. We are grateful to everyone who rallied around us to help ensure its success!

OCTOBER 2020

The article, "Direct and indirect associations between loneliness and thoughts of self-harm among a clinical sample of older adults with serious mental illness," was published in the October 2020 edition of the The Journal of Nervous and Mental Disease. The recent study was completed by Places for People's Research and Evaluation program. Authors included Nathaniel A. Dell, AM, MSW, LCSW; Jin Huang, Ph.D; Kayla A. Buttafuoco, B.S.; Kristina R. Vidovic, MSW; Allison M. Murphy, MSW, LMSW; and Leon A. Farrar, MSW, LCSW.

Youth and Family flu vaccine clinic goes mobile, providing flu vaccines to 40 youth, sometimes on their front porches, to adhere to COVID-19 restrictions and guidelines.

PFP launched the Clinical BEACN project in partnership with BHN and Mercy Hospitals to reach the highest utilizers of the ER.
