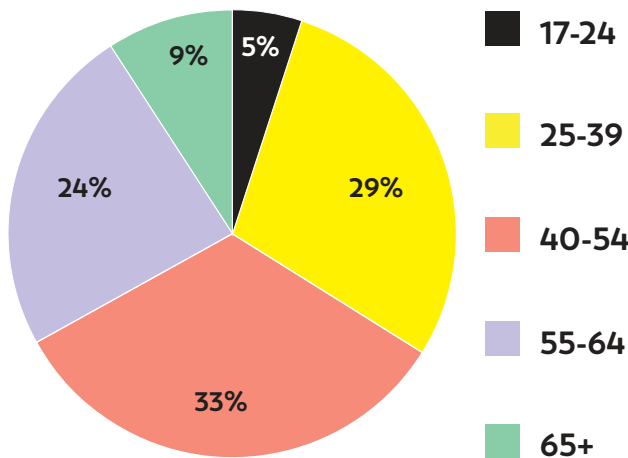

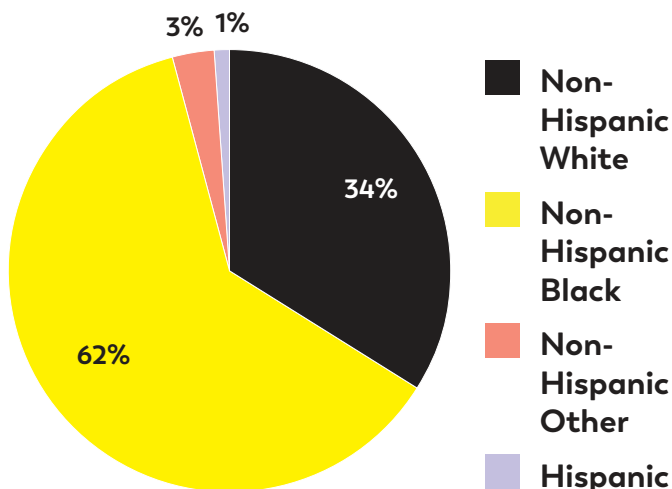

# Highlights

## SEPTEMBER 2021

Participated in the Missouri Attorney General's press conference about the opioid settlement.

The CMHC Grant began, which provides \$2,872,261 over 2 years. It helps serve un-insured and under-insured individuals and provide support and wellness resources to the PFP staff.

Hosted the 19th Annual Golf Tournament at Missouri Bluffs.

Held the "Black Girl, Bleu" documentary movie screening and panel discussion at PFP.

## OCTOBER 2021

One of the PFP Pioneers, Gary Morse, who helped co-found Illume: The Behavioral Health Center of Excellence, retired.

## DECEMBER 2021

The PFP Holiday Program provided gifts for 277 children who are either served by PFP or whose primary caregiver is served by PFP.

## JANUARY 2022

Mary Kitley, the new Vice President of Development, joined PFP.

## APRIL 2022

ARPA Grant began, which was awarded by St. Louis City. It provided \$659,880 to support bridge housing services to unhoused individuals.

PFP announced a partnership with Mission: St. Louis that led to the two being co-located on North Grand in St. Louis. PFP extended substance use disorder (SUD) and co-occurring disorder services (COD) to North St. Louis. Illume: The Behavioral Health Center of Excellence provided training and technical assistance to community members and professionals serving people with SUD to further enhance this partnership.

PFP celebrated 50 years by having a Birthday Kickoff Week April 25-29. It featured activities for staff and persons served, "Tour Tuesday", "Birthday Blitz" fundraiser, and a happy hour. The "Birthday Blitz" fundraiser exceeded its \$100,000 goal by raising \$135,475 total.

## JUNE 2022

The final draft of the new strategic plan was presented to all staff.

PFP started the Young Professionals Council, which is a group of community members in the St. Louis region.

Gaming for Mental Health, a Fund-A-Need fundraiser, took place at Pieces: The St. Louis Board Game Bar & Cafe.
